SHAMROCK TOWNSHIP REGULAR BOARD MEETING Thursday March 5, 2020

Board Chairman Charles Quale called the meeting to order at 1:00 p.m. and led the Pledge of Allegiance. Present were Supervisors Ron Smith and Allen Eld; Treasurer John Brula; Clerk Candace Kral; maintenance Tim Turner and 3 property owners (sign in sheet attached).

Motion by Allen Eld, seconded by Ron Smith, to approve the March 5, 2020 agenda; motion carried.

Motion by Allen Eld, seconded by Ron Smith, to approve the February 13, 2020 Regular Board Meeting minutes; motion passed unanimously.

Motion by Ron Smith, seconded by Allen Eld, to approve the February 13, 2020 Board of Audit and Budget Meeting minutes; motion passed unanimously.

The treasurer reported the following fund balances for the period ending, February 29, 2020: General Revenue Fund, \$130,414.22; Road & Bridge Fund \$136,009.83; Sewer Fund, 25,039.97; Road Repair (blacktop) Fund, \$78,143.38 Fire Fund, \$20,145.41; Building Repair Fund, \$296,350.57; Parks & Rec Fund, \$90,715.09; Road Bond \$203,889.24 and the Lease/purchase \$15,577.85; bond principal -\$444,000.00 – for a total in the checking accounts of \$995,285.56. The Blacktop Repair CDs' total \$155,195.68; Equipment CD's total 50,000.00 and the Sewer Fund CDs' total \$92,054.97. Money market interest received in February 2020 was \$287.81. Receipts for the month were \$36,679.05. February disbursements were \$37,441.78. Motion by Allen Eld, seconded by Ron Smith, to approve the treasurer's report; motion passed unanimously.

The board discussed the extra payment to be made to the bond principle. It was decided to change the payment amount to \$200,000, making it an even payment amount. Motion made by Ron Smith, seconded by Allen Eld, to approve the March 2020 claims with the adjustment of the bond payment to \$200,000 and payroll totaling \$343,351.35; motion passed unanimously. OLD BUSINESS:

Road Report – Tim Turner reported they put ice blades on the grader; scraped and sanded roads; replaced seals in the Sterling; on Grader has an oil leak and need to replace air compressor; fixed ice ridge at Indian Portage Access; checked other accesses; worked on frozen culvert on 186th Ave; need new gauge cluster in pickup; speed signs need 400' straight stretch to read speed, will do

some temporary spot checking; suggested that the power company be asked for permission to use power poles for temporary sign installation

Salt Shed – no new information

- Shamrock Recreation Area Project the clerk received a call from a playground company who would like to bid our park equipment and stated that they also have a 50/50 match grant available
- DNR Grant Application the draft application was reviewed and a few changes were suggested, WSB has sent the draft to the DNR for their review for completion before the final application is submitted
- DNR Lease Extension Charles Quale and the Clerk will be meeting with Joe Rokala, DNR, regarding information to discuss the lease extension.
- Katie Nelson approached the board regarding the township's Park & Rec Fund. She has done research within the community and the county auditor as to the impact of a \$100,000 increase to the Park & Rec Fund would be to people and property taxes. She inquired of the board's opinion of her suggesting the fund be raised \$80,000 rather than the board's recommended \$10,000 to the residents at the annual meeting. Stating that this increase would bring the fund to \$100,000 enabling the park project to be completed in a more timely manner. The board further discussed the pros and cons of this suggestion, informing her that it would be her decision to make the suggestion and the resident's to approve the levy. The clerk will make copies of the park master plan and estimate for the annual meeting.

New Full-time Employee - tabled

Clean-Up Day – the board was presented with a chart of fees by 3 companies that were contracted regarding dumpsters for clean-up day. The board reviewed the information, noting that electronics are an issue with all companies. Various options for dumpster pricing and what to do regarding electronics were discussed. It was decided that at this time Countryside offers more beneficial services and pricing.

Full-time Employee – will be further discussed at a later meeting.

The taxable market value and net tax capacity report from the Aitkin County Auditor was distributed for review. For the assessment year 2019/tax year payable 20 the township's total taxable market valuation is \$461,532,895 and the net tax capacity is \$4,735,888.
